Section 64 developer charges

BACKGROUND

Section 64 of the Local Government Act, 1993 enables a local government authority to levy developer charges for water supply, sewerage and stormwater. This derives from a cross-reference in that Act to section 306 of the Water Management Act, 2000.

This document provides a summary of the current indexed water supply and wastewater supply developer contribution rates for the City of Coffs Harbour (the City).

The rates are updated and indexed from the City's Water Supply Development Servicing Plan and Wastewater Development Servicing Plan which are available for review on the City's contributions webpage.

CALCULATION OF CONTRIBUTIONS

This document provides a summary of current rates for the most common residential and commercial development types.

Contributions for various types of development are calculated on the basis of the applicable ET
